***EXCEPT AS OTHERWISE ORDERED, motions to continue and/or to vacate a hearing and approve stipulations relating to matters set for hearing must be filed no later than 12:00 p.m. the day prior to the hearing. The parties shall also call chambers at (720) 904-7310 to advise that the motion or stipulation has been filed.** The Court may not consider motions to continue and/or to vacate and approve stipulations filed after 3:00 p.m. Parties filing such motions shall be prepared to appear in person at the time scheduled for the hearing.

Each individual attorney must file an entry of appearance in a specific case, **or a specific pleading** in CM/ECF if he/she wants to receive notices and orders in a specific case. The Clerk's office cannot capture the information from attorneys whose **ONLY** appearance is during a telephonic hearing or other proceeding in the courtroom. The failure to an attorney-specific entry of appearance in a case will likely result in the attorney not receiving notices and orders from the Court and possibly not receiving pleadings from other parties in the case.
