Judgment Index Report

- A new report is now available to record judgments as required by Bankruptcy Rule 5003(c).
- Bankruptcy Rule 5003(c) requires the Clerk of the bankruptcy court to:
 - keep a correct copy of every final judgment, or
 - order affecting title to or lien on real property, or
 - for recovery of money or property.

Judgment Index Report

- The Judgment Index Report will be available to both court staff and PACER users.
 - This report is not subject to the 30-page limit for PACER charges.
 - Your court can configure which judgment events will display for selection on the report.
