## GENERAL PROCEDURE ORDER NUMBER 2002-1

THIS MATTER arises *sua sponte* upon the need to redistribute cases and proceedings previously assigned to Chief Judge Marcia S. Krieger in an equitable and timely manner. Accordingly, effective March 4, 2002, it is
