Parties shall deliver to opposing counsel a list and photocopies of the proposed exhibits pre-marked for identification (Debtor-Numbers, Objector-Letters, if there are multiple Objectors, designate exhibits by creditor name as well) and a schedule of witnesses who may be called as well as a schedule of witnesses who will be called, and file with the Court only the list of exhibits and schedules of witnesses who may or will be called. The original plus one copy of each exhibit shall be tendered to the Court at the commencement of the hearing. The copy shall be used by the Court and the original shall be used by the witness(es).

Unless a written objection is filed, the plan may be confirmed as unopposed upon the filing of a Motion and Verification of Confirmable Plan by the Debtor(s) pursuant to Transitional Local Bankruptcy Rule T.L.B.R.3015-1.
